By-Law No 16, the Town of Salisbury Municipal Plan, is amended by changing the designation as shown on the Future Land Use Map Schedule A of the Town of Salisbury Municipal Plan, for the property known as PID 01052695 as shown on Schedule "A-1" attached hereto and forming part hereof, from Rural designation to Industrial designation.



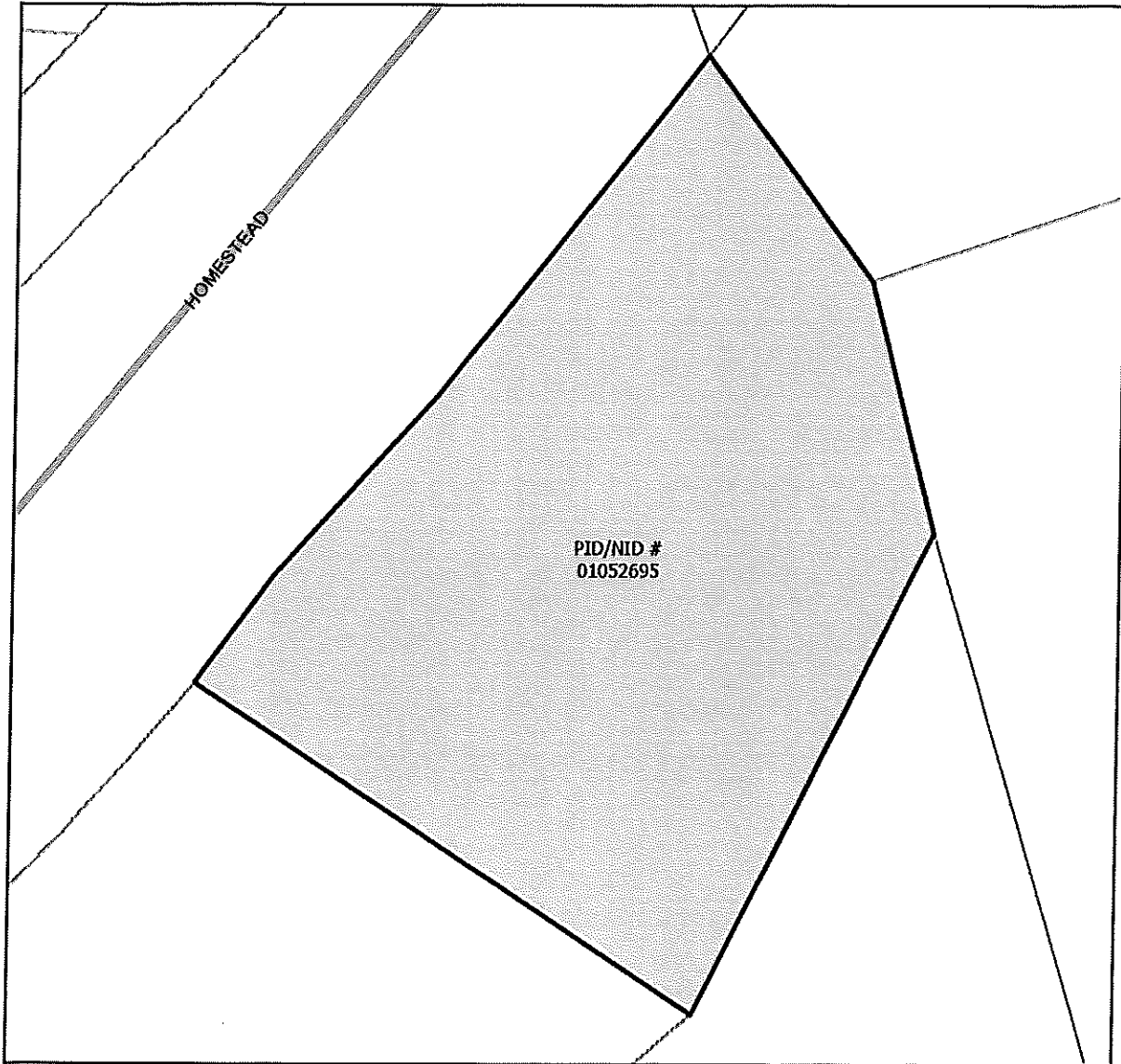

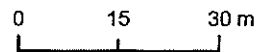

 Redesignation of PID 01052695 from Rural to Industrial




**SOLEMN DECLARATION
